ARTICLE 68(2)

SPECIAL DELEGATION OF POWER

I, VENKATESWARA SUBRAMANIAM MANI, Chief Secretary/Public Service Commissioner of the Republic of Nauru, IN EXERCISE of the powers vested in me by Clause (2) of Article 68 of the Constitution, as well as section 7 of the Public Service Act 1961-1979, DO HEREBY DELEGATE to DIRECTOR OF CIVIL AVIATION in the Department of Island Development and Industry, such powers as are vested in me pursuant to sub-clause (b) of Clause (1) of Article 68 of the Constitution, to the extent necessary to institute disciplinary proceedings under Section 73 of the Public Service Act 1961-79 against any officer(s)/employee(s) of his Directorate, to enquire into any conduct of such officer(s)/employee(s) chargeable under Section 65 of the Public Service Act 1961-1979 and/or under contract of employment, and make a report to the Chief Secretary/Public Service Commissioner through the Secretary of the Department of Island Development and Industry.
