(Directorate of Lands & Survey)

- POSITION : DIRECTOR, LANDS & SURVEY
- SALARY : A\$13,953 - A\$15,081 (S.1) per annum
- DUTIES : Responsible to the Secretary for Island Development and Industry for the administration of the Directorate of Lands & Survey, comprising of survey drafting and titles records sections. The Director will assume overall responsibility for:
- (a) cadastral, engineering and detail survey, complex survey will be done personally;
