IT IS NOTIFIED for general information that with the consent of the candidates who have been nominated to stand for the General Parliamentary Election to be held on Saturday, 9th December, 1989, a draw of lots was arranged and conducted in the presence of the Returning Officer and the Electoral Registrar in the Chief Secretary's Office on 4th December, 1989 at 3.00 PM in order to determine the order in which the names of candidates shall be printed on the ballot papers.

2. is seriously ill or infirm to the extent that he/she is precluded from attending a polling place to vote;
3. (In the case of a woman) is precluded by approaching maternity attending at a polling place to vote;
4. has some other valid and sufficient reason for not voting. (to the satisfaction of the Returning Officer).
