CONSTITUTION OF NAURU

CABINET APPOINTMENT UNDER ARTICLE 21

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE VINSON DETENAMO, M.P. BEING THE MINISTER FOR WORKS AND COMMUNITY SERVICES AND A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU DURING THE PERIOD OF ABSENCE OF HIS EXCELLENCY PRESIDENT BERNARD DOWIYOGO, M.P. FROM THE REPUBLIC.

ASSIGNMENT OF RESPONSIBILITY FOR THE

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT,  
UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, BERNARD DOWIYOGO,
