CABINET APPOINTMENT UNDER ARTICLE 21

IN EXERCISE OF THE THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE KINZA CLODUMAR, M.P. BEING THE MINISTER FOR FINANCE AND A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU DURING THE PERIOD OF ABSENCE OF HIS EXCELLENCY PRESIDENT BERNARD DOWIYOGO, M.P. AND THE MINISTER ASSISTING THE PRESIDENT, THE HONOURABLE VINSON DETENAMO, M.P. FROM THE REPUBLIC.

ASSIGNMENT OF RESPONSIBILITY FOR THE
