APPOINTMENT OF ACTING CHIEF SECRETARY,

REGISTRAR OF BIRTHS, DEATHS AND MARRIAGES

IT IS NOTIFIED for general information that Cabinet has, at its meeting held on 1st June, 1992, pursuant to Article 25, Clause (1) of the Constitution of Nauru, approved the appointment of MR LEO D. KEKE, the substantive Presidential Counsel to simultaneously act as:-

- i) Chief Secretary;
- ii) Secretary to the Cabinet; and
- iii) Registrar of Births, Deaths and Marriages,
