NAURU ISLAND COUNCIL ACT 1992

NAURU ISLAND COUNCIL (PAYMENT OF ALLOWANCE) REGULATIONS

1992

IN EXERCISE of the powers conferred by Section 95 of the Nauru Island Council Act 1992, the Cabinet has made the following Regulations -

SHORT TITLE

1. (1) These Regulations may be cited as the Nauru Island Council (Payment of Allowances) Regulations 1992.

(2) The Regulations shall come into force on a date to be notified by the Cabinet in the Gazette.

PAYMENT OF ALLOWANCES

2. (1) The Head Chief, Deputy Head Chief and the Councillors as specified in column 1 of the Schedule shall be paid the allowances specified in column 2 thereof.

3. (1) The allowances specified in Regulation 2 shall be paid in arrears each calendar month with effect from 2nd May 1992.

(2) In the event of a Councillor ceasing for any reason to hold the office of Head Chief, Deputy Head Chief or Councillor the allowance to which he was entitled shall be paid pro-rata on a daily basis to the end of the day of such cessation.
