ARTICLE 23

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS ~~IN THAT~~ BEHALF VESTED IN THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, BERNARD DOWIYOGO, M.P., PRESIDENT OF THE REPUBLIC OF NAURU, HEREBY ASSIGN TO THE MINISTER OF THE CABINET OF NAURU THE RESPONSIBILITIES FOR THE BUSINESS OF THE GOVERNMENT AS SET OUT OPPOSITE HIS NAME:-

THE PORTFOLIO OF THE MINISTER FOR EDUCATION IN RELATION TO THE BUSINESS OF THE GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

THE ASSIGNMENT OF BUSINESS OF GOVERNMENT OF NAURU AS SET OUT ABOVE ARE IN ADDITION TO AND NOT IN SUBSTITUTION OF THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTER. THE ABOVE ASSIGNMENTS OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT SHALL BE EFFECTIVE DURING THE PERIODS OF ABSENCE OF THE MINISTER FOR EDUCATION, THE HONOURABLE PRES NIMES EKWONA, M.P. FROM THE REPUBLIC.
