NAURU POLICE FORCE ACT 1972

POLICE REGULATIONS 1972  
(REGULATION 19)

I, DEROG GIOURA, Minister for Justice of the Republic of Nauru, by virtue of the powers vested in me under Regulation 19 of the Police Regulation 1972 made under the Nauru Police Force Act 1972, DO HEREBY direct that each of the Reserve Officers of the Nauru Police Force Reserve shall be paid normal hourly overtime rate payable to a Constable for each hour or part of an hour of duty on training which he performs or undergoes as an officer of the Nauru Police Force Reserve.

(Section 4)

I DEROG GIOURA, Minister for Justice of the Republic of Nauru, by virtue of the powers vested in me under Section 4 of the Nauru Police Force Act 1972, DO HEREBY establish a body of Reserve Officers to be called the Nauru Police Force Reserve. I direct that the Reserve would be established in the ranks of Constables and with effect from the dates given in the attached list of these appointees.
