Applications are invited from Nauruans both inside and outside the Public Service for appointment, promotion or transfer to the following position:-

DEPARTMENT OF EDUCATION

POSITION : Executive Officer (Youth Affairs)  
SALARY : A\$15670-17290 pa (AP6/7)  
DUTIES : Responsible to the Director of Education to:  
DEVELOP FORWARD PLANNING:

1. Plan and administer yearly programmes which will provide maximum opportunities for youth development.
2. To prepare in conjunction with the Director of Education a three-to-five-year plan for Youth Affairs and to review and assess programmes in accordance with long-term goals.

DEVELOP YOUTH POLICY:

3. To liaise appropriately with the Commonwealth Youth Programme and other international youth organisations.
4. To attend meetings relevant to Youth Affairs (including Principal's meetings) and to organise and/or support meetings which relate to youth activities.

ADMINISTER AN ANNUAL YOUTH ACTIVITIES PROGRAMME:

5. Plan and coordinate training programmes for local youth (over 16 years) who do not have access to mainstream educational opportunities.
6. Prepare and administer an appropriate budget for youth opportunities in accordance with approved plans for the calendar and financial years.

7. To supervise and develop staff employed at Youth Affairs in accordance with the youth Policy and Goals.
8. To facilitate the work of all Youth Affairs in accordance with the Youth Policy and Goals.
9. To oversee a programme of Work Experience for Youth, in conjunction with Nauru Secondary School and Kayser College.
10. Provide and after school activities/training programme in cooperation with the Departmental Special Projects Officer and/or Activities Officer concerning after school activities.
11. To interview and encourage potential youth members for training programmes and other youth programmes.
12. To be available at all times during office work hours for consultation with and for the youth of Nauru.

**SUMMARY OF DUTIES** : Plan, supervise and monitor a youth development programme for the Republic of Nauru. In so doing, provide a link between government and non-government organisations to ensure that the youth of Nauru have the best possible opportunities to develop beyond school towards their optimum potential.

**QUALIFICATIONS** : The applicant requires experience in youth work the social sciences or a related field, along with experience in leading and supervising youth on a formal basis. (teaching experience would be advantage.) The applicant also requires skills in administration, staff supervision, group work and communication at all levels. Knowledge of social frameworks and agencies overseas would also be an advantage.

Applications should be lodged in writing stating name, age, and experience with the Acting Public Service Commissioner no later than 4.30 pm on Friday 1st March, 1996.
