No candidate received an absolute majority of 1st Preference votes. Therefore **Mr. Johnny Panser Olsson** who has received the fewest first preference votes is declared a defeated candidate and the Ballot Papers counted to **Mr. Johnny Panser Olsson** were distributed amongst the non-defeated Candidates next in order of the Voters' Preference (i.e. according to the second preference marked) and the Total number of voters given to each non-defeated Candidate was ascertained as follows:-
