CONSTITUTION OF NAURU

ARTICLE 23

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, **I KINZA CLODUMAR, M.P. PRESIDENT OF THE REPUBLIC OF NAURU**, HEREBY ASSIGN TO THE MINISTERS OF THE CABINET OF NAURU THE RESPONSIBILITY FOR THE BUSINESS OF THE GOVERNMENT AS SET OUT OPPOSITE THEIR NAMES:-

THE ABOVE ASSIGNMENTS SHALL BE EFFECTIVE DURING THE PERIOD OF ABSENCE OF MINISTER FOR ISLAND DEVELOPMENT AND INDUSTRY, CIVIL AVIATION, AND EDUCATION, HON BERNARD DOWIYOGO, M.P., FROM THE REPUBLIC.

ARTICLE 23**

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

BUSINESS OF GOVERNMENT
