**CONSTITUTION OF NAURU
ARTICLE 23
ASSIGNMENT OF RESPONSIBILITY FOR THE
BUSINESS OF GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, **I. BERNARD DOWIYOGO, M.P., PRESIDENT OF THE REPUBLIC OF NAURU**, HEREBY ASSIGN TO THE MINISTERS OF THE CABINET OF NAURU THE RESPONSIBILITY FOR THE BUSINESS OF THE GOVERNMENT AS SET OUT OPPOSITE THEIR NAMES:-
