**CONSTITUTION OF NAURU
ARTICLE 23
ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT**

IN EXERCISE ON THE POWERS IN THAT BEHALF VESTED IN THE PRESIDENT UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I BERNARD DOWIYOGO, MP, PRESIDENT OF THE REPUBLIC OF NAURU, HEREBY ASSIGN TO THE MINISTERS OF THE CABINET OF NAURU THE RESPONSIBILITY FOR THE BUSINESS OF THE GOVERNMENT AS SET OUT OPPOSITE THEIR NAMES:

MINISTER OF CABINET	BUSINESS OF GOVERNMENT
HON. VINSON DETENAMO, MP	THE PORTFOLIOS OF THE PUBLIC SERVICE, EXTERNAL AFFAIRS, AND HEALTH & YOUTH AFFAIRS AND WORKS & COMMUNITY SERVICES, IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.
HON. REUBEN KUN, MP	THE PORTFOLIOS OF THE MINISTER FOR FINANCE IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.
HON. VASSAL GADOENGIN, MP	THE PORTFOLIOS OF ISLAND DEVELOPMENT & INDUSTRY, AND CIVIL AVIATION AS THE CIVIL AVIATION AUTHORITY, IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

THE ASSIGNMENT OF BUSINESS OF GOVERNMENT AS SET OUT ABOVE IS IN ADDITION TO AND NOT IN SUBSTITUTION OF THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTERS. THE ABOVE ASSIGNMENTS OF RESPONSIBILITIES SHALL BE EFFECTIVE DURING THE ABSENCE OF HIS EXCELLENCY THE PRESIDENT BERNARD DOWIYOGO.
