PRACTICE NOTE NO. 1 OF 2002

LAND APPEALS

APPEALS TO THE SUPREME COURT AGAINST
DETERMINATION OF THE NAURU LANDS COMMITTEE

1. An appeal from a determination of the Nauru Lands Committee is by Notice.
2. Every Notice of Appeal to the Supreme Court against the determination of the Nauru Lands Committee must be in writing and signed by the appellants, or his solicitor/pleader. Where there are several appellants appearing jointly, by each of them or their solicitor or pleader.
3. The Notice of Appeal must be set out substantially in the following manner:
 - (a) Name/s of the Appellant/s;
 - (b) Name of Land, Portion No. and District;
 - (c) No. of Government Gazette in which the Nauru Land Committee's determination is published;
 - (d) Grounds of Appeal.
4. A copy of the relevant gazette shall be filed along with the Notice.

5. Sufficient number of copies of the Notice of Appeal should be filed by the appellants/s for service on the determined beneficiaries, the Nauru Lands Committee, and the Director of Lands and Survey.
6. The Notice of Appeal must be lodged in the Supreme Court Registry. The Clerk receiving it will endorse upon it forthwith the date of receipt, assign it a serial number, place it in case file cover endorsed with the number and enter the details in the court register of land appeals.
7. The clerk will ascertain from the Government Gazette the names of those shown as having been determined as the owners and will enter them in the register and on the case file as respondents. If, either before the appeal is lodged or afterwards another appeal is lodged in respect of the same land, every appellant in that appeal will be added as respondent in the other appeal and his name entered in the register and on the case file cover.
8. The Clerk within 7 days of the receipt of the Notice of Appeal will arrange for a written notice along with a copy of the Notice of Appeal, to be delivered to the Secretary of the Nauru Lands Committee, the Director of Lands and Survey and every respondent, informing them of the appeal and of the grounds of appeal.
9. The Secretary of the Nauru Lands Committee, upon receipt of a Notice informing him of an appeal, will send to the Registrar of the Supreme Court within 21 days thereafter a written statement in the English Language:
 - (a) Giving each appellant's claim to the land, as presented to the Committee;
 - (b) Each respondent's claim to the land, as presented to the Committee; and
 - (c) The committee's reasons for their determination of the matter.

The statement should be substantially in the following form:

10. A copy of the Committee's statement will be supplied by the Registrar to the appellant and respondent upon request.
11. If an appellant wishes to amend his grounds of appeal he should file in the Registry of the Supreme Court, not less than 7 days before the hearing of the Appeal, a Notice setting out the amendment. The amendment may be by way of alteration or deletion of any of the original grounds or by way of adding further grounds or both. Upon the notice of amendment of the grounds appeal being filed, the appellant who filed the amendment shall serve a copy of the same on the respondent/s or on the legal representative of the respondent, if any.
12. As soon as he is able to do so the Registrar will assign a date for the hearing of the appeal.
13. As an appeal to the Supreme Court against a determination of the Nauru Lands Committee is made under section 7 of the Nauru Lands committee Ordinance, the respondents are the beneficiaries so determined by the Nauru Lands Committee. The Nauru Lands Committee is not to be named as a respondent.
14. This Practice Note replaces an earlier direction issued on 16th March 1970.
