**CONSTITUTION OF NAURU
ARTICLE 21**

**ASSIGNMENT OF RESPONSIBILITY FOR THE
BUSINESS OF GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE DEROG GIOURA, BEING MINISTER FOR PUBLIC SERVICE, MINISTER FOR FOREIGN AND INTERNAL AFFAIRS, MINISTER FOR CIVIL AVIATION, MINISTER FOR FISHERIES & MARINE RESOURCES AND WOMEN'S AFFAIRS, MINISTER RESPONSIBLE FOR NAURU PHOSPHATE ROYALTIES TRUST, MINISTER RESPONSIBLE FOR AUDIT AND TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU.
