**CONSTITUTION OF NAURU
ARTICLE 21**

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE HONOURABLE MARCUS STEPHEN, MP BEING:

- MINISTER FOR TREASURY
- MINISTER FOR FOREIGN AFFAIRS
- MINISTER FOR RONFIN
- MINISTER FOR THE BANK OF NAURU
- MINISTER FOR PUBLIC WORKS AND SERVICES
- MINISTER FOR WOMEN'S AFFAIRS AND CULTURE
- MINISTER FOR ENVIRONMENT AND INTERNAL AFFAIRS
- MINISTER FOR SMALL BUSINESSES
- MINISTER FOR NPRT
- MINISTER FOR RONTEL
- MINISTER FOR EDUCATION, TRAINING AND EMPLOYMENT
- MINISTER RESPONSIBLE FOR GOOD GOVERNANCE
