**CONSTITUTION OF NAURU  
ARTICLE 21**

**ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT THE **HON. KIEREN KEKE, MP** BEING A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE 5<sup>TH</sup> AUGUST, 2004 UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT.
