EMERGENCY POWERS**

**PRESIDENTIAL ORDER 11**

By Virtue of the powers in that behalf vested in me under Part IX of the Constitution of Nauru, and all other powers enabling me, I, Ludwig Scotty, President of the Republic of Nauru, DO HEREBY order the release of funds for additional part-payment of salary to Police Officers and Reserves, to the sum of \$ 5,150 (130 officers/reserves at \$50 each), and an additional \$2,000 for Police rations; that is the grand total of \$7,150.

**PUBLIC PROCLAMATION  
PRESIDENTIAL DECLARATION  
UNDER PART IX OF THE CONSTITUTION**

**PRESIDENTIAL ORDER 12**

Pursuant to the Public Proclamation (1) and Presidential Declaration dated 30<sup>th</sup> September 2004, and under powers vested in me in accordance with part IX Article 77 (5) of the Constitution of Nauru, I, Ludwig D. Scotty, President of Nauru, further declare that it is reasonably required that the state of emergency will remain in force until the election of a President after the Parliamentary General Election on the 23<sup>rd</sup> October, 2004.
