**LEGAL PRACTITIONERS (PRACTISING CERTIFICATES) (FEES)
REGULATIONS 2005**

IN EXERCISE of the powers conferred on me by Section 23 of the Legal Practitioners Act 1973, I hereby make the following Regulations-

SHORT TITLE

1. These Regulations may be cited as the Legal Practitioners (Practising Certificates) (Fees) Regulations 2005, and shall come into force on 1st January, 2005.

FEES

2. The fees payable to the Registrar by the Practitioners for the issue of practicing certificate shall be those set out in the Schedule to these Regulations.

REPEAL

3. The Legal Practitioners (Practising Certificates) (Fees) Regulations 1973 are hereby repealed and replaced by these Regulations.

COURTS ACT 1972-1999

COURTS ACT (FEES) RULES 2005

IN EXERCISE of the powers conferred on me by Section 74 of the Courts Act 1972-1999, I hereby make the following rules of Court

SHORT TITLE

1. These rules may be cited as the Courts Act (Fees) Rules 2005.

RULES OF COURT SET OUT IN SCHEDULE

2. The Rules of Court set out in Schedule to these Rules shall, so far as they are applicable and stated, apply in the Supreme Court and District Court.

REPEAL

3. Any rules of court made previously and in force immediately before these regulations which are contrary to the rules set out in the schedule to these rules are hereby repealed.

 - C. Where the Court is required to serve a document a fee is charged for the service and subsequent affidavit of service.
