**FOOD SAFETY ACT 2005**

**DECLARATION OF PROHIBITED PRODUCT**

**Poultry and Poultry product from certain countries**

In accordance with subsections 18(2) and (3) of the Food Safety Act 2005, I, Hon. **Dr. Kieren Keke, Minister for Health**, being satisfied that as a consequence of the risk posed to the health and welfare of Nauruans by the introduction of foods contaminated by Avian Influenza Virus (type H5), **By This Order declare to be a prohibited product** under subsection 18(1) of the said Act those food listed in the column 1 of the Schedule that originate in or are imported from the countries listed in the second column to be prohibited products, the importation into Nauru of which is prohibited.

A person found guilty of –

- (a) importing a prohibited product; or
- (b) declaring or holding out a prohibited product to have originated or been imported from a place other than that from which it actually originated or was imported

is liable upon conviction to a fine not exceeding \$5,000 or to imprisonment of up to 2 years.
