**PRICES REGULATION ACT 2008**

**PRICES REGULATION ORDER**

Pursuant to powers vested in me under Sections 5(3) and 6(1) of the *Prices Regulation Act 2008* to determine the maximum wholesale prices and retail margin for the said declared goods and in accordance with the advice of the Secretary for Finance and approval of Cabinet, I make the following orders:

- a) Maximum whole sale prices for diesel and petrol
  - diesel: \$1.86/litre; and
  - petrol: \$1.75/litre.
  
- b) Maximum retail margin for diesel and petrol-
  - diesel: 30cent/litre; and
  - petrol: 30cent/litre.

Acting on the advice of the Secretary for Finance pursuant to Section 5 (3) of the *Prices Regulation Act 2008*, I am satisfied that it is necessary to act without delay in order to ensure the fair distribution of these goods among all members of the community.

**PRICES REGULATION ACT 2008**

**TEMPORARY RATIONING ORDER**

Pursuant to powers vested in me and after the advice of the Secretary for Finance and with the approval of Cabinet under Section 11 of the *Prices Regulation Act 2008*, I make the following order:

1. That Capelle's may supply only 250 kgs of rice to any other trader, or another person acting on behalf of that trader.
2. That Capelle's may supply only 750 kgs of rice per day to the general public including a maximum of 25 kgs of rice per customer.

**PRICES REGULATION ORDER**

Pursuant to powers vested in me under Sections 5(3) and 6(1) of the *Prices Regulation Act 2008* to determine the maximum retail price for the said declared good and in accordance with the advice of the Secretary for Finance and approval of Cabinet, I make the following order:

Maximum retail price for Rice

- Rice: \$2.12/kg.

Acting on the advice of the Permanent Secretary for Finance pursuant to Section 5 (3) of the *Prices Regulation Act 2008*, I am satisfied that it is necessary to act without delay in order to ensure the fair distribution of these goods among all members of the community.

Traders should have scales available to evidence the weight of rice being sold to customers
