ARTICLE 21

ASSIGNMENT OF RESPONSIBILITIES FOR THE
BUSINESS OF GOVERNMENT

PITCHER, M.P.**, BEING A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE EIGHTH JULY, TWO THOUSAND AND EIGHT UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT.
