DUTIES AND RESPONSIBILITIES:

- The Bus Conductor is responsible for the safety of passengers on buses and the smooth operation of the bus to transport students, public servants and the general public as necessary. The bus conductor is accountable to the Director for Land Transport and reports to the Transport Officer in ensuring that work procedures are implemented, that standards and outcomes are met and that continuous improvement of effective service is implemented.
