**EXTENSION OF EXCISE EXEMPTION FOR FUEL AND EQUIPMENTS IMPORTS FOR RONPHOS AND NAURU REHABILITATION CORPORATION**

It is notified for general information that Cabinet approved the Customs Tariff (Exemption) Regulations 2009 pursuant to the Customs Tariff Act 1997-2006.

1. Exempt from customs duty all fuel (including petrol and diesel), used by RONPHOS or NRC for their own consumption; and
2. Reduce the rate of duty on imports by RONPHOS and NRC of machinery and vehicles from the current rate of 25 per cent to the normal customs duty rate of 8 per cent where the goods are not for the purposes of re-sale.

The exemption apply for a period of 12 month from 1<sup>st</sup> July, 2009 to 30<sup>th</sup> June, 2010.
