- Petrol: \$1.34 per litre.

b) Maximum retail margin for diesel and petrol

- Diesel: \$0.30 per litre; and
- Petrol: \$0.30 per litre.

This order shall remain in force until the next Prices Regulation Order relating to fuel prices is issued.
