**CONSTITUTION OF NAURU
ARTICLE 40(1)
PROCLAMATION**

WHEREAS the Eighteenth Parliament of the Republic of Nauru was dissolved on the 20th day of March, 2010.

AND WHEREAS by a writ issued by the Speaker and with the advice of the President dated the 20th day of March 2010 the Speaker appointed the twenty-fourth day of April 2010 for the holding of a general election of Members of Parliament in accordance with the advice of the President.

AND WHEREAS I have received the Return of the said writ notifying me that the said general election was duly held and of the names of the persons elected thereat.

I, SHADLOG BERNICKE, in accordance with the advice of the President DO APPOINT AND PROCLAIM that the Nineteenth Parliament of Nauru shall meet at Parliament House in District of Yaren at the hour of Ten o'clock in the morning of Tuesday, twenty-seventh day of April 2010 and shall proceed to transact the following business,

NAMELY –

FIRST, the election of a Member of Parliament to be Speaker of Parliament,

SECONDLY, the election of a Member of Parliament to be Deputy Speaker of Parliament

THIRDLY, the election of the two Members of Parliament to be Deputy Chairman of Committees,
And in that order before the transaction of any other business,

AND PARLIAMENT MUST at its first sitting thereafter elect a Member of Parliament to be President of Nauru.
