INSTRUMENT OF DELEGATION

I, Mathew Batsiua, Minister for Justice and Border Control, under section 50(1) of the *Passports Act 2011*, delegate the following powers to the person from time to time holding the office of Secretary for Justice and Border Control:

1. the power to issue an ordinary Nauruan passport or a travel-related document under section 6 or 11 of the Act, unless the exercise of the power requires the exercise of discretion under section 15(2);
2. the power to request information under section 48 of the Act;
3. the power to disclose information under section 49 of the Act; and
4. the power to endorse or make observations on a Nauruan travel document under section 55 of the Act.
