ARTICLE 21

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF
GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT HON. DOMINIC. TABUNA, M.P. BEING A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE SEVENTEENTH, OCTOBER TWO THOUSAND AND TWELVE UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT.

ARTICLE 23

ASSIGNMENT OF RESPONSIBILITIES FOR THE BUSINESS OF GOVERNMENT
