**CONSTITUTION OF NAURU**  
**ARTICLE 21**

**ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT **HON. SHADLOG BERNICKE, M.P.** BEING A MEMBER OF THE CABINET OF NAURU TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE SECOND SEPTEMBER 2013 UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT OR IF HON. DAVID ADEANG, MINISTER ASSISTING THE PRESIDENT SHOULD RETURN BEFOREHAND SHALL PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT .
