**ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT HON. VALDON DOWIYOGO, M.P., BEING A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE TWENTY-SIXTH, JULY 2014 UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT HON. BARON DIVAVESI WAQA M.P. OR HON. DAVID ADEANG M.P. MINISTER ASSISTING THE PRESIDENT.
