ARTICLE 21

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT **HON.DAVID ADEANG M.P.** MINISTER ASSISTING THE PRESIDENT AND A MEMBER OF THE CABINET OF NAURU TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE FROM NINETEENTH FEBRUARY 2014 UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT.
