SPECIAL ALLOWANCE FOR HEALTH DEPARTMENT EMPLOYEES

It is notified for general information that Cabinet at its meeting held on 24th March, 2015 consider and approve the following;-

1. Shift Allowance

Employees performing a role assigned the rostered operation or operations working pattern will be paid a Night Shift allowance of \$20.00 and \$25.00 respectively for each performed between the hours of 0000-0800. (12.00 midnight-0800 hours)

2. On-Call Allowance

1. Employee will be entitled to be paid an on-call allowance for each period of up to 24 hours (or part thereof) as outlined below.
 - a. \$20-Monday to Friday
 - b. \$25-Saturday, Sunday and Public Holidays;

3. Re-Call Allowance

1. Employees agrees to be re-call in excess of seven days in a 28 day period, they will be paid the following re-call allowance for any additional days as following:
 - a. \$20-Monday to Friday
 - b. \$25-Saturday, Sunday and Public Holiday;
2. Employee is in receipt of an on-call allowance, they must remain available to be recalled to duty.

4. Hazardous, Dirt Material Handling & Risk Allowance

All health employees qualified under this scheme, irrespective of positive will be paid a HDMH and risk allowance component of \$50 across the board per fortnight pay in addition to shift allowance. This should be reflected separately in their pay slip during every pay cycle

5. No overtime will be paid to the Health Officers

6. No Time Off in lieu of extra work will be given to health officers.
