**ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT**

DAVID ADEANG M.P, MINISTER ASSISTING THE PRESIDENT OR THE RETURN OF HIS EXCELLENCY THE PRESIDENT HON. BARON DIVAVESI WAQA M.P.
