ARTICLE 21**

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT HON DAVID ADEANG, M.P BEING A MEMBER OF THE CABINET OF NAURU TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE ON THE TWENTY-SIXTH DAY OF JUNE 2016 UNTIL THE RETURN OF HIS EXCELLENCY THE PRESIDENT HON. BARON DIVAVESI WAQA, M.P.

ARTICLE 23
