Cabinet makes the following Regulations under section 243 of the Corporations Act 1972:

#### 1 Citation

These Regulations may be cited as the Corporations (Fees) Regulations 2017.

#### 2 Commencement

These Regulations commence on the day they are notified in the Gazette.

#### 3 **Definitions**

In these Regulations:

'Act' means the Corporations Act 1972;

'Registrar' means the Registrar of Corporations.

#### 4 Fees

The fees to be paid to the Registrar under the Act are set out in Schedule 1 of these Regulations.

#### 5 **Prescribed forms**

- (1) The prescribed form for the incorporation of a corporation is set out in Schedule 2 Form 1 of these Regulations.
- (2) The prescribed form for the renewal of a Certificate of Incorporation is set out in Schedule 2 Form 2 of these Regulations.
- (3) The prescribed Annual Return Form is set out in Schedule 3 of these Regulations.
