ARTICLE 21**

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT **HON. DAVID RANIBOK ADEANG, M.P** OR HIS EXCELLENCY THE PRESIDENT **HON. BARON DIVAVESI WAQA, M.P.**
