#### REGISTRATION AND TRANSFER OF VOTERS NOTIFICATION

The following key can be used to identify the reason of transfer or registration of each voter.

- 1. The District is registered as his/her place of birth in the Register of Births
- 2. He/she is living in the District new and has been living in the District for more than one (1) month
- 3. He/she is living outside Nauru and immediately before he/she ceased to live in Nauru he/she had been living in the District for more than one (1) month

That he/she has connection to the District through:

- 4. Nauru custom, customary links and affiliation;
- 5. It is the District of birth of his/her mother/father;
- 6. His/her father/mother is registered to vote in that District;
- 7. It is the District of birth of his/her spouse.
