The Cabinet makes the following Regulations under *Section 46* of the *Dog Management and Control Act 2017*:

1 Citation

These Regulations may be cited as the *Dog Management and Control (Licensing of Dogs) (Amendment) Regulations 2021*.

2 Commencement

These Regulations commence on the day they are notified in the Gazette.

3 Amendment of Dog Management and Control (Licensing of Dogs) Regulations 2018

These Regulations amend the *Dog Management and Control (Licensing of Dogs) Regulations 2018*.

4 Insert new Regulation 7A

A new Regulation 7A is inserted as follows:

7A Fixed Penalty Notice – failure or neglect to report dog attack

(1) For the purposes of Section 20(4) of the Act, a Fixed Penalty Notice for failure or neglect to report a dog attack on a person or animal is in Form 5 of Schedule 1.

(2) A person who is issued with a Notice under subregulation (1), shall pay the fixed penalty within 7 days of service of the Notice.

5 Insert new Regulation 7B

A new Regulation 7B is inserted as follows:

7B Licensed Dog Seizure Notice

For the purposes of Section 28(2) of the Act, a Licensed Dog Seizure Notice is in Form 6 of Schedule 1.

6 Amendment of Regulation 8

Regulation 8 is deleted and substituted as follows:

8 Penalty and cost

For the purposes of Section 29 of the Act, the owner of the dog shall pay the penalty and cost in Schedule 2 on reclaiming his or her dog.

7 Amendment of Schedule 1

Schedule 1 is amended by inserting new Forms 5 and 6
