Annual salary / band level – AUD54,710.00 / 16.1. The remuneration package includes leave entitlement benefits and membership under the Superannuation Scheme.

**Special condition:** The position is subject to the conditions applying under the Parliamentary Services (Employment & Procedure) Regulation 2021. The appointee will be required to work extended hours to meet the exigencies of the Parliament. The key challenge in this role is that ‘any person who is, or is seen to be active in political or electoral affairs, and intends to publicly carry on this activity, may compromise the strict political neutrality of this position and cannot be considered’.

**Summary roles:**

The position reports to the Clerk of Parliament and other key relations the positions interact with. The primary role is to manage and supervise daily support operations for the Secretariat and specifically the Legislation Division to meet its work target production. Lead team of work colleagues to ensure to complete a range of administrative duties in different sections of the Secretariat and ensure work is carried out efficiently and effectively to function properly. The key challenge in this role is ‘any person who is, or is seen to be active in political or electoral affairs, and intends to publicly carry on this activity, may compromise the strict political neutrality of this position and cannot be considered.’

**Key responsibilities:**
