**CONSTITUTION OF NAURU  
ARTICLE 21**

**ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT**

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, THE CABINET OF THE REPUBLIC OF NAURU DOES HEREBY APPOINT **HON. RENNIER GADABU, M.P.**, BEING A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU EFFECTIVE ON THE 10<sup>TH</sup> DAY OF FEBRUARY 2023 UNTIL THE RETURN OF EITHER THE MINISTER ASSISTING THE PRESIDENT, HON. MARTIN HUNT, M.P OR HIS EXCELLENCY THE PRESIDENT, HON. RUSS JOSEPH KUN, M.P.
