G.N.No. 207/2024 (Cont'd)

Any failure to renew a business licence in a timely manner will result in the cessation of all business operations and or the imposition of penalties (including criminal prosecution) under the *Business Licences Act 2017*.

- Renewal fee is \$300 for each business nature.
- Late Submission fee is:
- (a) \$100 in less than 30 days of expiry of the licence;
- (b) \$200 after the expiry of a licence.
- Additional penalties will be imposed for operating a business with an expired licence.

Authorised officers will be conducting regular on-site inspections of all businesses.

Business owners or licensees should display their business licences conspicuously on the premises and must produce licences to authorised officers upon request.
