## AN ORDINANCE

*To Amend the "Justices Ordinance, 1912-1920."*

**B**E it ordained by the Legislative Council for the Territory of Papua, in pursuance of the powers conferred by the *Papua Act, 1905-1940*, as follows:—

1. (1) This Ordinance may be cited as the *Justices Ordinance, 1940*. Short title and citation.

(2) The *Justices Ordinance, 1912-1920*, is in this Ordinance referred to as the Principal Ordinance.

(3) The Principal Ordinance as amended by this Ordinance may be cited as the *Justices Ordinance, 1912-1940*.

**2.** Section Seventeen of the Principal Ordinance is amended as follows:—

- (a) By omitting the words "Ordinance past or future or by this Ordinance" and substituting the following words in their stead "law for the time being in force in the Territory"; and
- (b) by inserting immediately after the word "person" first occurring the following words "is liable to be prosecuted summarily or"; and
- (c) by omitting the words "the Ordinance" and substituting the words "any such law" in their stead.

**3.** The Principal Ordinance is further amended in the manner set forth in the Schedule to this Ordinance.
