LAND (NEW GUINEA) ORDINANCE 1950.⁽¹⁾

No. 6 of 1950.

An Ordinance to amend the Land Ordinance 1922-1941 of the Territory of New Guinea.

BE it ordained by the Governor-General in and over the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the *Papua and New Guinea Act 1949*, as follows:—

1.—(1.) This Ordinance may be cited as the *Land (New Guinea) Ordinance 1950*.⁽¹⁾

Short title
and citation.

(2.) The *Land Ordinance 1922-1941*⁽²⁾ of the Territory of New Guinea is in this Ordinance referred to as the Principal Ordinance.

(3.) The Principal Ordinance, as amended by this Ordinance, may be cited as the *Land Ordinance 1922-1950*.

PART C: LAND—

Mortgage of agricultural or dairying leases.

2. Section twenty-two of the Principal Ordinance is amended by inserting in sub-section (4.) after the word "Agricultural" the words "or dairying".

Classes of land.

3. Section twenty-seven of the Principal Ordinance is amended by inserting in sub-section (2.) after the word "agriculture" (twice occurring) the words "or dairying".

Agricultural and dairying leases of Class "A" lands.

4. Section thirty-two of the Principal Ordinance is amended—
- (a) by inserting in sub-section (1.) after the word "leases" the words "or dairying leases";
 - (b) by inserting in sub-section (2.) after the word "lease" (first occurring) the words "or a dairying lease"; and
 - (c) by inserting in sub-section (3.) after the word "lease" (first occurring) the words "or a dairying lease".

Deposit payable with application for a lease.

5. Section thirty-three of the Principal Ordinance is amended by inserting in sub-section (1.) after the word "lease" (first occurring) the words "a dairying lease".

Agricultural and dairying leases of Class "B" lands.

6. Section thirty-four of the Principal Ordinance is amended by inserting after the word "lease" (first occurring) the words "or a dairying lease".

Improvement conditions in case of agricultural and dairying leases.

7. Section thirty-eight of the Principal Ordinance is amended by inserting in sub-section (1.) after the word "leases" the words "and dairying leases".

Mining on agricultural, dairying and pastoral leases.

8. Section forty-two of the Principal Ordinance is amended by inserting after the word "leases" (first occurring) the words "dairying leases".

Rent when payable.

9. Section fifty-seven of the Principal Ordinance is amended by inserting in sub-section (2.) after the word "leases" (first occurring) the words "dairying leases".

Fine may be imposed for non-fulfilment of improvement conditions.

10. Section sixty-two of the Principal Ordinance is amended by inserting in sub-section (6.) after the word "agricultural" the word "dairying".
