

BUSINESS NAMES REGULATIONS.⁽¹⁾

REGULATIONS 1935, No. 5.

- Short title.** 1. These Regulations may be cited as the *Business Names Regulations*.⁽¹⁾
- Definition.** 2. In these Regulations, unless the contrary intention appears, “the Ordinance” means the *Business Names Ordinance 1935*.
- Register.** 3. The register kept under section 16 of the Ordinance shall be known as the “Register of Business Names”.
- Time for compliance with demand for statement.** 4. Any person who by the Ordinance is required to send or deliver any statement and upon whom a written demand in that behalf is made by the Registrar, shall comply with that demand within twenty-eight days from the date of the letter of demand or within such longer period as may be stated therein.
- Certificate of registration of firm or person.** 5.—(1.) A certificate of the registration of a firm shall be in accordance with Form A in the First Schedule to these Regulations.
(2.) A certificate of the registration of a person shall be in accordance with Form B in the First Schedule to these Regulations.
- Form of registration of change in firm or person.** 6. Whenever a change is made or occurs in any of the particulars required for registration in respect of any firm or person, the firm or person shall send by post or deliver to the Registrar a statement in writing in accordance with Form C, D, E, or F in the First Schedule to these Regulations, whichever is applicable.
- Size of paper.** 7. All documents sent or delivered to the Registrar under the Ordinance or these Regulations shall be upon foolscap paper of a size approximately thirteen and a half inches by eight and a half inches and shall have on the left hand part thereof a margin of approximately two inches.
- Fees.** 8.—(1.) The fees to be paid under the Ordinance and these Regulations shall, if paid at the office of the Registrar, be paid in cash or, if sent by post, be remitted by money order, postal note, or bank draft made payable to the Registrar.
(2.) Excepting where provided for in the Ordinance, the fees payable under the Ordinance or these Regulations shall be those specified in the Second Schedule to these Regulations.
