

# SUPERANNUATION REGULATIONS. <sup>(1)</sup>

1. These Regulations may be cited as the *Superannuation Regulations*. <sup>(1)</sup> Short title.

2. In these Regulations, unless the contrary intention appears— Definition.  
 “the Ordinance” means the *Superannuation Ordinance* 1928. <sup>(2)</sup>

3. Payments of Superannuation allowance in accordance with section fifteen of the Ordinance shall be made monthly. Payment of superannuation allowance.

4. Contributions payable, in accordance with sub-section (1.) of section sixteen of the Ordinance, or in accordance with sub-section (1.) of section seventeen of the Ordinance may be deducted in equal fortnightly instalments over such period not exceeding five years as is notified in writing to the Treasurer by any officer so contributing: Deduction of contributions in respect of past services, &c.

Providing that any amount remaining unpaid or any part thereof may be paid by such officer at any time within the period of five years specified in sub-section (2.) of those respective sections.

5. An application for—

(a) a superannuation allowance under section 14 of the Ordinance; or

(b) a refund of contributions under section 23 or section 24 of the Ordinance,

6. An application for a superannuation allowance under section 18 or section 19 of the Ordinance shall be in accordance with Form B in the Schedule to these Regulations.

7. A person in receipt of a superannuation allowance or pension under the Ordinance shall, whenever so required by the Treasurer or the Officer-in-Charge, Trade Agency Section, Commonwealth Treasury, Sydney, in the State of New South Wales, furnish to him, within fourteen days, a certificate—

- (i) in the case of a superannuation allowance under section 14 of the Ordinance—in accordance with Form C in the Schedule to these Regulations;
- (ii) in the case of a superannuation allowance under section 18 or section 19 of the Ordinance—in accordance with Form D in the Schedule to these Regulations; and
- (iii) in the case of a pension under section 20 of the Ordinance—in accordance with Form E in the Schedule to these Regulations.
