Customs Tariff (Amendment) Act 1994,

Being an Act to amend the *Customs Tariff Act 1990,*

MADE by the National Parliament to come into operation on 8 March 1994.

1. AMENDMENT OF SCHEDULE 1.

Schedule 1 to the Principal Act is amended -

- (a) by repealing the rate of duty specified as "10%" in the rate of duty columns within the following Tariff Chapters, except for those Items shown under Paragraph (b), and replacing it with "11%":-

Chapters 1, 2, 4 to 8, 10 to 16, 19 to 23, 25 to 29, 31 to 43, 45, 46, 48 to 56, 58 to 60, 62 to 65, 67 to 76, 78 to 90 and 94 to 97; and

- (b) by repealing the rate of duty specified as "10%" in the rate of duty column opposite the following Tariff items and replacing it with "11%":-

- (c) by repealing the rate of duty specified as "30%" in the rate of duty columns with the following Tariff Chapters and replacing it with "33%":-

Chapters 1, 2, 4, 5, 9, 11, 12, 14 to 21, 23, 27, 32 to 36, 38 to 40, 42 to 49, 56, 58, 59, 61 to 70, 72 to 76, 78 to 80, 82 to 85, 87 to 90 and 94 to 96; and

- (d) by repealing the rate of duty specified as "50%" in the rate of duty columns within the following Tariff Chapters and replacing it with "55%":-

Chapters 3, 4, 6 to 9, 11, 13 to 17, 20 to 23, 33, 34, 36 to 39, 41, 42, 44, 48, 57, 67 to 71, 73, 82 to 85, 87, 90 and 93 to 96; and

(e) by repealing the rate of duty specified as "K10.00 per litre" in the rate of duty column opposite the Tariff Item NO. 2710.00.11, and replacing it with "K0.20 per litre".

2. AMENDMENT OF SCHEDULE 2.

Schedule 2 to the Principal Act is amended by repealing Item 44.03 and replacing it with the following:-
