

CUSTOMS TARIFF, 1915. ⁽¹⁾

An Ordinance relating to Duties of Customs.

BE it enacted by the Lieutenant-Governor of the Territory of Papua with the advice and consent of the Legislative Council thereof as follows:—

1. This Ordinance may be cited as the *Customs Tariff, 1915.* ⁽¹⁾ Short title.

2. *The Customs Ordinance of 1909* ⁽²⁾ (No. 34 of 1909) and the *Customs Ordinance, 1913* ⁽²⁾ (No. 16 of 1913) shall be incorporated and read as one with this Ordinance. Incorporation.
