

# CUSTOMS TARIFF, 1922.<sup>(1)</sup>

## An Ordinance relating to Duties of Customs.

**B**E it enacted by the Lieutenant-Governor of the Territory of Papua with the advice and consent of the Legislative Council thereof as follows:—
