TEXT OF NOTICES.

[Notice dated 17th December, 1914, and published in Papua Govt. Gaz. of 6th January, 1915.]

Government Secretary's Department,
Port Moresby, 17th December, 1914.

It is hereby notified, for general information, that His Excellency the Lieutenant-Governor has established the township or town of Port Moresby as a Dog District under the provisions of the *Dog Ordinance*, 1913.

For the purposes of the said Ordinance the boundaries of the said township or town shall be:—

All that piece of land that is bounded by the waters of the sea and by the following line, that is to say— Beginning at the point on the sea shore of Ela Beach that would be met by a prolongation of the Eastern boundary of the road called Lawes Street; thence by such boundary Northwards to the most South-western point of the surveyed allotments of Granville East; thence by a line following the back or inland boundaries of the said allotments to the most North-eastern point; thence by a straight line following the most Northern boundary of such allotments and prolonged to the sea shore of Port Moresby harbour.
